2. 12:40 AM - 1:00 PM Superintendent Search

Minutes:

Earlier in the month, Dr. McKinzie notified School Board Members of her intent to resign effective November 1, 2010. Mrs. Fields asked Board Members if they preferred to have a nation-wide, state-wide or in-house search for her replacement. She has contacted Dick Greene of Hazard, Young, and Attea (the firm used on the first superintendent search) and the cost would probably be the same as it is based on the number of students within the district.

Previous search expenses:

• Consultant fee \$46,000

• Miscellaneous \$12,000 (finalists' travel, Board travel, moving costs)

Board consensus:

Mr. Harris - based on the fact that our district is among the top 40 largest in the nation, he would like a national search.

Mrs. Lofton - a national search is her perference: looking for someone presently in a superintendent position or has experience with a large school district. Someone that has

risen from teacher, principal, district office to a superintendent position. She would also like to have input from business partners and community and possibly receive help with the expenses from business sector.

Mrs. Fields stated she did talk with Hunt Berryman (World Class Education) who indicated he would be willing to approach his organization for help with the expenses.

Mrs. Cunningham - also supports a national search. Candidates should be a sitting superintendent.

Mr. O'Reilly - would support a national seach but requested that it be expanded to include either a sitting superintendent or assistant superintendent of at least five years.

Mr. Mullenax - agreed it should be a national search for a sitting superintendent.

Mrs. Sellers - will support a national search and agreed that it should not be limited to sitting superintendents. With the current economic situation, costs involved and salary should also be considered. When the search was initiated six years ago, we were told that if you were not going to offer a salary above \$150,000, then you shouldn't be looking nationally. That was 7 years ago. She simply wants the best person. The best person might be working with the district now.

Consensus for a national search. Mrs. Fields will approach Hunt Berryman to see if he is able to assist financially.

- Mrs. Sellers asked for information on the average nation-wide salary.
- Mr. Harris asked for a listing of appointed superintendents, district size, and salaries within the state.
- Mr. O'Reilly requested that Dr. McKinzie be actively involved in the process.

Minutes:

Mark Grey, Assistant Superintendent of Business Services, reported the district would like to make two on-site health care clinics available to our employees.

Joy Myers reported that the on-site clinics would offer:

- convenience and ease of use exclusively for employees (silimar to urgent care clinics)
- we would be able to set hours of operation
- lower health care cost for employees and health plan
- · opportunity to enhance wellness and employee health initiatives
- enhance quality of patient care by improved adherence to evidence-based medicine and apropriateness of referrals

Seven proposals were reviewed by SIC Steering Committee which resulted in onsite interviews for the top three vendors: HealthStat; CRAssociates; and WellCenters. A recommendation to negotiate with the top-ranked vendor, HealthStat, will be submitted for School Board approval on February 9, 2010.

Scope of Services requested (to be negotiated)

- staffed by MD, ARNP, RN/MA, other support staff
- two onsite clinics initially
- primary care medical services (routine and urgent care)
- ancillary medical services (lab and radiology)
- medication dispensing and managment
- integration with health plan partners that will include referral of members to providers that are considered to be high performing with high quality outcomes.
- member support and coaching to faciliate optimal outcomes when sick and when well.
- health management services (health screening, disease management)
- communication and reporting

Clinic Costs - Start Up

- facility design and build out
- equipment and furnishings
- · information services
- · administrative oversite, licensing, insurance

On-going monthly costs

- facility lease(s)
- staffing
- administrative
- medical services and supplies

Range of costs of RFPs were: \$525,000 start up; \$312,000 monthly, fully staffed.

Currently the City of Lakeland and Polk County Board of Commissioners offer on-site clinics to their employees. Lakeland has been offering limited services to their employees for three years. It might be possible to work with Lakeland (who has approximately 2,200 employees) to see if they would like to join services and sites.

Mr. Mullenax stated that the main objective is to provide services for our 22,000 employees, retirees and dependents. If we asked the City of Lakeland to enter an agreement with us, then others will follow; such as Polk State College and other cities within the county.

Mr. Grey agreed that the focus should and would remain on our 22,000 members.

Several in-house programs presented:

- IDEAS Interactive Data Evaluation and Assessments Systems prior to the development of this program, the district paid an outside firm \$10 per student per year to maintain data that was not accessible online. Over the past four years, this program has saved the district approximately \$5 million. Now, with the program developed and maintained by district staff, the information is accessible 24/7 through the internet. Type of reporting information: student by teacher /by school/ race/grade/ELL / lunch/ retention/ AYP count/ migrant.
- Teleconferencing with Webcams
- · Record meetings online
- Live meetings

Mr. Taguri stated that Dr. McKinzie's instructions to him 5 years ago was to provide equity in schools across the district. His division has worked diligently to meet her expectations.

Minutes:

Dr. McKinzie reported that after the School Board's discussion on Race to the Top's MOU where it was the consensus to be an Involved District along with several other school districts across the state. Seminole County submitted an amended MOU that was denied. After the established deadline, FI DOE reported they had accepted Seminole's addendum. The Federal law states that, if the state so wishes, any district can be allowed to participate after 90 days of the award of funds.

Those districts remaining as 'Involved', including Polk County, used language from the amended MOUs and sent the revisions to Tallahassee but they have been denied.

Now, after four districts received exceptions, DOE is saying that they have not approved the addendums of Seminole and Duval.

A conference call is scheduled for Wednesday with the Chancellor.
