Superintendent LeRoy announced that community meetings to discuss the proposed changes were held on:

- October 10 at Dundee Elementary and Dundee Ridge Middle
- November 24 at Lake Marion Creek
- December 9 at Lake Marion Creek and
- January 23 at Lake Marion Creek

Information was provided at the meetings relating to converting Lake Marion Creek to a Middle School, IB programs at Dundee Elementary and Dundee Ridge Middle, new magnet programs, early high school program, and rezoning.

The Superintendent reported that Dundee Elementary, Laurel Elementary and Palmetto Elementary Schools will become grades PreK-4; Dundee Ridge Middle and Lake Marion Creek Middle will become grades 5-8.

Students displaced by the Dundee Elementary Magnet program are rezoned to the traditional elementary schools (PreK-5): Alta Vista Elementary, Elbert Elementary and Sandhill Elementary. Students displaced by the Dundee Ridge Magnet program are rezoned to traditional middle schools (6-8): Denison Middle, McLaughlin Middle, Boone Middle or the reconfigured middle school Lake Marion Creek (5-8).

Reconfiguring Lake Marion Creek will allow the majority of students living in Poinciana the opportunity of attending Poinciana schools from PreK-8. A small portion of Laurel Elementary is rezoned to Palmetto Elementary. Elementary students currently zoned for Lake Marion Creek Elementary will be rezoned to Laurel Elementary for grades Pre-K and return to Lake Marion Creek Middle for grades 5-8. They will be joined at the middle school by students from Palmetto Elementary and Laurel Elementary.
