C-11: Resolutions to Amend District 2014-2015 School Budget

Mr. Berryman questioned the per person Obamacare Reinsurance fees; information he has heard at the Central Florida Public School Boards Coalition implies that self-insured agents do not have to pay those fees. Mr. Perrone will research the information and report back

Superintendent Leroy announced that Governor Scott signed an Executive Order earlier today suspending testing for Grade 11 Florida Standards Assessment for English Language Arts. He is also requesting legislation to eliminate PERT (Post-secondary Education Readiness Test) as a state mandate for 11th Graders; eliminate the current progress monitoring requirements (Differentiated Accountability requirements); eliminate local final exams in courses that are also state-wide standardized tests (no end of course exam for Algebra 1, Algebra II, Geometry, US History, Biology, and Civics); and, districts are not to test students for the sole purpose to evaluate teachers (hopefully this will return teacher evaluation back to local control).

Minutes:

The Superintendent reported that unfilled positions were collapsed to allow other departments with critical needs to use the funds.

Mr. Berryman asked where the value is by adding four new people to a different department. Mrs. LeRoy responded that no staff were available to shift to this area; these were positions in Facilities and Operations that have gone unfilled for several years. The Assessment, Accountability & Evaluation Department has been understaffed for quite some time and their requirements have increased significantly. The value will be a reliable and valid assessment system; teachers will have the confidence (now that we are moving to performance pay) as they are evaluated that we have good, reliable, and valid assessments; accountability is a huge area because of the increase of schools identified in the Differentiated Accountability status; and through the teacher and district staff evaluation requirements.

Brian Warren, Acting Senior Director of Human Resources, summarized the need to revise the current procedures for promotions of Non-Union Employees and District/School-Based Administrators.

The revised language brings the employee in at the base level (step 1) and guarantees a 5% minimum increase. The Superintendent has the purview to intervene in the administrative appointments and placements. The revisions will affect very few employees: single digit numbers.

Mrs. LeRoy reported that the goal is to encourage individuals to grow into leadership positions.

Minutes:

Greg Rivers, Associate Superintendent of Facilities and Operations, summarized the main objectives of the Impact Fee Report which includes a comparative student generation rates table, an updated impact fee schedule, and a comparative of county fees of other school districts.

A comparative student generation rate is the number of students in the district divided by number of homes of that type (single family, multi-family, mobile home, etc.) Since the 2010 study, there has been a significant increase in the generation rates for the multi-family and mobile home permits; an increase of 60% in the multi-family homes. Which means that for every multi-family home, it generates .276 students per unit; for the mobile home, it generates .346 students per unit. The increase in rates led to the proposed impact fee increase.

The cost per student station to construct a school generates the impact fee cost. The report provided is a draft from the Board of County Commissioners; a final should be provided in August.

Mrs. Fields commented that the County Commission has the final say on the impact fee. Mr. Rivers stated that the county is assessing 40.5% of the current 2010 adopted rates. During 2011-2014, 80% of the building permits issued were single family, 16% multi-family, and 4% mobile home. Mr. Berryman asked if the 16% were in permits or units. Mr. Rivers will report back to the Board.

Mr. Harris pointed out that Table 143 shows that compared to the counties included in the study, Polk County has the lowest percentage of impact fees collected: Pasco -91%, Osceola- 62%, Orange- 73%, Lake- 72%, Manatee-50%, Hillsborough- 87%, and Polk is at 25%.

Mr. Rivers provided the school impact fees collected by the same districts: Hillsborough-109% Manatee- 0%, Lake- 75%, Orange- 100%, Osceola-

83%, Pasco- 100%. and Polk- 41%.

Mrs. Cunningham thought the document would be a good talking point with the County Commission and Legislators.

Mr. Rivers will see when the BOCC needs the School Board's recommendation.
