Minutes:

Mark Grey, Assistant Superintendent of Business Services, stated that the purpose of today's meeting is for permission to advertise a public hearing on the Tentative Budget.

Major components of the budget

- ARRA funds
- Tentative budget does meet the requirements of the 3% Unrestricted Fund balance. However, the flexibility of the fund balance continues to decrease as revenue funds are less and less.

Capital Outlay Tax - Local Improvement Millage

- projects funded by LCI decreasing rapidly as property tax values decrease.
- millage is \$1 for every \$1000 of property value

• homestead exemption is first \$25,000 of property value

Mr. Grey also noted an error in the DOE's template. It should read 'Critical Needs Millage' of 0.25% not 'Capital Operating Millage' of .25%.
