Dr. McKinzie requested Bob Williams, Assistant Superintendent of Facilities and Operations, to provide a brief update on our Energy Management program.

Mr. Williams reported that since 1991 our air conditioned square footage increased by 53.7% , yet our energy consumption only increased by 21.4%. We are using 22% less water than we did in 1991. Our energy reduction calculates to removing approximately 4,294 cars off the road each year or planting 131,200 acres of forest. Florida Department of Education recognizes Polk County as the most efficient district in the state (Polk County's average is .75 cent per sq foot - state wide average is \$1.31).

Ann Tankson, Senior Director of Reading, reported on our 12 summer reading camps. At the end of the summer program, with 704 students enrolled, 209 passed Portfolio D and 153 passed the SAT-10; a total of 362 or 51.4%. And, after including the Good Cause promotions (27 students), a total of 55.2% met the requirements to go to the next grade level.
