Minutes:

Mr. Harris stated that while he supports the proposal, he cannot support the location. Tenoroc High School was constructed two years ago for this area and is currently underpopulated. Mr. Harris feels the charter will further affect the school's enrollment.

Mr. Mullenax requested an approximate cost of an appeal should the application be denied. Wes Bridges, School Board Attorney, responded that chances are better when valid legal reasons can be articulated in the denial. An approximate cost, including travel and staff time, would be \$10,000. Mr. Mullenax stated he cannot support the concept of the school but will support the application rather than face potential legal fees through an appeal.

Mrs. Sellers commented she supports the concept of the school and, while she may not agree with the location, she understands the applicant's reasons for locating at Berkley Middle Academy. As a cost savings measure, they plan to utilize the staff of Berkley Middle during the first year of the charter.

Mrs. Lofton stated she will support the application because it is specifically for those students who devote 100% toward their education rather than extra curricular activities such as sports and the arts. The school will be 'nested' within Berkley Middle Academy.

Mrs. Fields commented she agrees with both Mr. Harris and Mr. Mullenax.

Minutes:

Dr. McKinzie reported she could not recommend PIVOT charter application for approval for the following reasons:

- Assessment piece is woefully inadequate. The only academic goal in the application states that by 2014 87% of those students enrolled for three or more years will achieve 3, 4 or 5 on the FCAT assessments taken at each grade level. There is no academic evaluation of the school for the first three years. This is totally unacceptable. The mobility factor of the county was never figured into the equation. At the end of the three year period, minus the juniors and seniors who have graduated and those students who have left the program, the 87% is based on 91 remaining students.
- The application provides conflicting information on how the principal will be selected. One area says a committee made up of various persons will make the selection. However, on page 12 it states that the management company, AAI, will select and hire the principal.
- Another area in the application provides the projected enrollment of ELL students as 82% or 205 students. They submitted a percentage used in standard applications across the state and did not take into consideration the makeup of Polk County.
- Their governing board will be made up of one member from Polk County and the others will be from around the state.

- The application also provides for a board member mentor to be assigned to each new board member; this is in direct violation of Florida's Sunshine Law.

Motion Minutes:

Mrs. Sellers supports the Resolution and hopes the parents and community understand the need to have this amendment approved. It is a very complex

and expensive issue. Schools enroll students nearly every day; whether they are new to the district or moving between schools. The spirit of the law will continue to be met; however the amendment will give us flexibility when the class is over the maximum allowed. There have been students that have been moved from 3 different classrooms already this year in order to meet the class by class size limit.

Mrs. Lofton stated that this amendment will do a great service to parents, students and staff. To date, implementation of the class size amendment has cost the state \$19 billion. Teachers have been moved between schools and students have been moved between classes. We strongly suggest the public look at the language and consequences of the legislation.

##### Minutes:

Superintendent McKinzie announced that the District will meet the class size requirements by Friday, the first day of the FTE count.

Dr. Tonjes summarized some of the events that took place:

- reassigned 43 teachers
- added 7 teachers
- added 35 sub teachers to co-teach (this is a moving target as students continue to enroll or transfer between schools)
- created 39 combination classes (K/1st and 3/4 are the major combination classes);
- gave high and middle schools permission to create 35 sections (class taught by teacher entire day rather than having planning period)
- approximately 4000 students have been affected by either moving from class or moving their teacher
- approximate cost since first day of school is \$800,000 (does not include 100 new teachers hired at the beginning of the school year)
