Motion Minutes:

Hazel Sellers explained the need to return the school to the traditional calendar: school is overcrowded and when the different tracks are off, classrooms are empty (which was not the original intent). It would be nice to have all schools on year-round calendars but the expense is too high. Valleyview is no longer surrounded by empty land as when it was built 18 years ago. If rezoning is not an option, the District will be busing students in that zone to schools outside of the area; incurring more costs. Every child is important. Our task was to remove between 200-250 students from the enrollment at Valleyview. The option was narrowed to allow those within the two mile zoned area remain and remove the Choice students.

Margaret Lofton said this was a decision that was not taken lightly and many hours have been involved in gathering the data and reviewing options.

Dr. Brenda Reddout received a suggestion that Valleyview be all Choice. She suggested that in the future that the idea be considered to create choice schools similar to Magnet and Academies. She commented that the new school, Spessard Holland, will be as great as Valleyview. Those families that are being relocated can help make it so.

Tim Harris empathizes with the parents and students and related that students will be allowed to have a continuing transfer to Spessard Holland through the 5th grade for those who choose to go during the initial transfer from Valleyview.

Kay Fields related this is one of the hardest decisions for a board member but



believes this is the best solution. Transportation and sidewalks were the deciding factors for her.

Chairman Cunningham understands that parents want the very best for their child. She encouraged parents to take the passion that was expressed tonight to the new school, talk with the administration there and become as involved at the new zoned school as you have been at Valleyview. You can make a difference.
