Minutes:

Information was presented by Angela Dawson, Representative for Polk Education Association (PEA), and Richard Arzillo, a teacher at Sleepy Hill Middle School. Ms. Dawson discussed information in the teacher contract pertaining to the steps of progressive discipline. Following a student related incident in the classroom, the principal stated she felt threatened by Mr. Arzillo. Ms. Dawson commented that Mr. Arzillo continued to work five days before he was notified of the Principal's intent to discipline him.

Attorney Donald Wilson, representing the Superintendent, stated this is a grievance of the Teacher Collective Bargaining Agreement (CBA). The employee behaved in a threatening and aggressive manner toward the Principal. The steps of progressive discipline were not followed because of the severity of the employee misconduct.

Mrs. Sellers stated the documentation that was provided indicates the Principal took action right away. Attorney Donald Wilson confirmed the Principal took appropriate action and contacted Human Resources Services and the Polk Education Association.

Mr. Townsend commented on the appropriateness of sending a teacher back to the classroom if they exhibited this sort of behavior.

Mrs. Fields commented her response to aggressive behavior in the presence of peers would be to send the staff member home immediately.
