#### Minutes:

Attorney Mark Herdman represented Kristen Turner. He requested the School Board Members send this matter back to the Administrative Law Judge for a determination to be made before a final order is voted on.

Attorney Donald Wilson spoke on behalf of the Superintendent. He commented that Ms. Turner, a teacher at Sleepy Hill Elementary, had previously received progressive disciplinary action for various issues that violated the rules of professional conduct.

Mr. Townsend asked for clarification of an Administrative Law Judge's (ALJ)

role.

Attorney Donald Wilson commented the appointment of an ALJ is requested from Tallahassee. The process is concluded when the judge makes a final determination with a recommended order. At that time, the respondent has an opportunity to file an exception to the ruling. The School Board Members then have the option to adopt the recommended order as the final order of the Board. The respondent can then appeal.

Attorney Mark Herdman commented the ALJ makes recommended findings of fact as defined in the Superintendent's charging document which he feels has not been accomplished. The School Board Members can then make their determination.

Mrs. Sellers asked if a judge is factually required by law to explain their decision to each question, either verbally or in writing.

Wes Bridges, Counsel for the Board, commented an Administrative Law Judge is required to make findings of fact, conclusions of law, and make a recommendation which the ALJ has done. He said there are instances when an ALJ recommendation is binding but that is not the case in this instance.

Mr. Lynn Wilson and Attorney Don Wilson discussed the number of student's that were affected by this teachers actions. It was an entire class, approximately twenty students.

Mr. Lynn Wilson asked for an example of "finding of fact" in this case. Mr. Herdman explained an example would be that the teacher knowingly and intentionally falsifed the grades. It is not disputed that the grades were entered erroneously but the intent has not been determined by the ALJ.

Mrs. Fields commented entering grades inaccurately for an entire class is neglectful and is not good for the students or the schools.

Mrs. Sellers reiterated a passage from the documentation provided that stated the respondent did not accept the responsibility for entering the grades falsely.

### Minutes:

Brenda Young represented herself. She commented on her years of employment in the Polk County School District without any disciplinary action. She explained a sequence of events that began in February 2016 involving the Kirk family and student transportation.

Mrs. Fields commented that the School Board Members cannot accept any new information or evidence regarding this case.
Attorney Donald Wilson stated Ms. Young's actions demonstrate a pattern of dishonest behavior.
Mrs. Fields commented on the importance of being straightforward and honest.
Mr. Townsend asked for clarification on Ms. Young's authority to alter transportation information. Attorney Don Wilson explained Ms. Young had the authority and there are many bus stops and assignments that take place daily. He also commented the consequences of the change are what is in question.
Ms. Young stated she made the change in the computer system to ensure no other students would be put in danger.
Mrs. Sellers referred to the documentation provided that indicated no one was notified that the changes were made.
Mr. Townsend asked if there are options available to the School Board besides termination or no action in this case. Wes Bridges, Counsel for the Board, commented the options are to adopt the recommended order of the hearing officer or not.
Mr. Lynn Wilson commented the legality of this situation could negatively affect the District.
