3. R-1 Permission to Advertise the Superintendent's 2016-2017 Tentative Budget

Minutes:

Jason Pitts, Director of Budget, stated the fund balance will be continually changing until the beginning of August. He discussed the increase from last year's millage rate.

Mr. Mullenax commented on the difference between the previously presented numbers and the current figures.

Mrs. Sellers asked if the tentative budget will change before the vote on the budget.

Mr. Pitts stated all of the numbers will shift over the next month.

Mr. Harris asked for additional information on the rollback rate.

Mike Perrone, Chief Financial Officer, explained this is the revenue that taxes

would have generated last year. The rollback rate this year is .62 less than last year.

Mr. Berryman commented on the \$10 million lapse.

Mr. Pitts explained historically lapse has not been budgeted.

Mrs. Sellers commented she thought the budget would include the lapse conservatively, and therefore be more reflective of what the actual fund balance is.

Mr. Berryman would like to budget the lapse or find a way to reduce expenditures in order to have a 5% fund balance.

Mr. Harris prefers the District start the school year with a 5% fund balance.

Mrs. Fields asked the financial team to take the information back and rework the calculations.

Mr. Mullenax stated his position is the fund balance should start with 5% but that suggested this be discussed at future Work Sessions.

Mr. Wilson stated he does not think the district is in a position to make major budget cuts this late in the game.

Superintendent Byrd stated in looking at upcoming year, the intent is to begin next year with 5% as the floor. More budget meetings are being scheduled to create guidelines.
